- 6. Linda was covered by her mother's health insurance.
- 7. The Box 8 interest from Acme Bank is tax-exempt both federally and in New Jersey
- 8. Linda received a 1099-MISC for her participation in drug trial for Acme Pharma
- 9. Linda negotiated a deal with her bank to close out a credit card account They issued a 1099-C as a result. Linda was solvent and not contemplating bankruptcy.
- 10. She did not make any out of state purchases for which she would owe Use Tax.
- 11. Linda lives with her parents, Henry and Anne Howe.
- 12. Linda would like any NJ refund/amount due to be handled the same as her federal return.
- 13. She has had no involvement of any kind with foreign financial institutions.
- 14. You will need to figure out Linda's Modified AGI to use on her parent's (Henry and Ann Howe) return.
